{i} Resumption of operations at the Sathamangalam Unit in Tamil Nadu:

- (a) This is further to our intimation dated Mar 26, 2020 regarding the temporary shutdown of our Plants situated at Kattur and Sathamangalam, due to the outbreak of Coronavirus (COVID-19).
- (b) In the wake of Government's measures to ensure uninterrupted supply of essential commodities, the manufacturing units of essential commodities and food products are allowed to run their operations under the strict safety guidelines issued by the Government. In line with this, after assessing and reviewing the availability of harvesting labourers, employees and safety of the various stakeholders and Government norms, we would like to inform that the operation of the Sathamangalam unit is resumed from Apr 01, 2020.
- (c) The Company has taken adequate measures to follow the Government regulations and directives to ensure the safety and health of the employees, labourers and all stakeholders.
