The Notice was also published in "**Business Standard**" (English) and "**Makkal Kural**" (Tamil) on July 16, 2026.
- (iii) The members of the Company holding shares as on the "**Cut-off**" date (i.e. on Friday, August 07, 2026) have cast their votes through e-mail facility provided by the Company to their designated e-mail address ksdho@hckgroup.com.
